Our next issue is following the lead of the legislators, It has been almost a year since a Judge heard our case against the State of Michigan over the 10 million dollars appropriated in the budget for VEBAs established during a bankruptcy, and he still has not responded with a decision. Not much we can do but wait.

As you can see, by the length of my articles, they have been getting shorter and shorter. The reason for this is that our Association has no major issues to address. However, that's not to say we aren't monitoring The City, State and Federal governments to make sure we're aware of any changes that could affect our members.



The following is the Retired Detroit Police and Fire Fighters Associations previous year activities, income and expenses from January 1, 2025 to December 31, 2025.

A direct quote from the Restated Bylaws of the Retired Detroit Police and Fire Fighters Association states, in part, "The purposes of the Association shall be: To provide the Members with information concerning the status of Pensions, Hospitalization and Insurances." The organization achieves pension issue goals by supporting two elected pension representatives, one fire and one police, who in return report to the membership on all relevant activities. Hospitalization Benefits, are regularly monitored by elected Trustees, three are RDPFFA Board of Director members who report to the participants all applicable information.

Additionally, the Retired Detroit Police and Fire Fighters Association objective is to promote a spirit of good fellowship and a closer personal relationship among members and their families. Attempting to accomplish this goal the Association arranged an annual picnic along with a sponsored event at a casino, furthermore the RDPFFA coordinates a golf outing. The Association is organized and shall be operated exclusively for the purposes set forth in Section 501(c) (4) of the Internal Revenue Code.

This is a summary of year end numbers compiled by the Retired Detroit Police Fire Fighters Association Secretary-Treasurer. Over 4,500 persons were participants in the Association at the end of 2025, of those included, 3,635 started the year on payroll deduction and the Association ended the year with 3,507 on payroll deduction. Other members are those not enrolled who pay annually along with persons not eligible for automatic payroll deduction.

The following list represents categories identifying annual expenses; Events \$5,700 (11 donations), General Membership Meetings \$18,811., Honorariums \$41,540,


Insurance \$5,980. (Average yearly cost - 3 year policies), Office Expenses \$60,736, Payroll Expenses \$66,613, Legal Fees \$35,853, Professional Services \$6,498, Professional Fees /Lobbyist \$200, Property Taxes \$9,315, Unity Magazine \$13,162 and Utilities \$12,511 along with a variety of categorized operating cost which is \$209,552 total for building improvement or repairs. A majority of the Associations assets are professional manage and the investment expenses are not included in this piece of writing.

The yearly Retired Detroit Police and Fire Fighters Association expenses as of December 31, 2025, were \$486,490. The Association had a total income of \$199,555; this number includes \$144,813 in dues, \$22,635 in appreciation and \$32,107 in other income. The dues assessment of \$36.00 annually does not cover the Association's annual expenses which then, are supplemented by transferring investment funds. In 2025, \$337,966 of investment earnings was transferred to the Association's fund to deal with expenditures.

December 31, 2024 total expenses was \$486,490 December 31, 2023 total expenses was \$330,112, December 31, 2022 end of the year total expenses was \$338,283, December 31, 2021 end of the year total expenses was \$261,118.

Left out from the above values of total assets is the office located at 2525 E. 14 Mile Road Sterling Heights, Michigan 48310-5969 which is owned by the organization. The above numbers are calculations for members' informational purposes only and are not to be construed as a professional audit and official certified numbers.

DEATH OF MEMBER FAMILY ASSISTANCE PROCEDURE

Communications vary whether member was Police, Fire, or Sergeant and above. If you are Police make your first call to the Detroit Police Benefit & Protective Association, (313) 870-9304. Followed by either a call to the Detroit Police Officer Association, (313) 567-8770, or the Lieutenants & Sergeants (313) 961-5699, which ever applies.

While the Detroit Police Benefit & Protective Association will normally contact the City of Detroit with the information it would be reasonable to follow up with a call to the Pension Bureau, (313) 224-3362 Ext. 221 or 1 (800) 339-8344 and BeneSys (833) 725-5336 to make sure that they were notified. Last but not least, notify the Retired Detroit Police & Fire Fighters Association, (586) 795-1734.

Fire employees, start by notifying the Detroit Fire Fighter Association, (313) 962-7546, the Detroit Firemen's Fund Association, (313) 628-0099, Detroit Fire Mutual Fund call Firemen's Fund Association to leave a message, Detroit Pension Bureau, (313) 224-3362 or (800) 339-8344, ext 221 and BeneSys (833) 725-5336.

The above agencies will assist you with the notification process. It would be a good idea to put this information with your secured legal documents or some other obvious place where your survivors can locate it.

The Significance of the Maltese Cross

From the days of the first crusade, the cross has been the symbol of the Christian warrior who pledged not only to fight in defense of the Holy Land, but also to protect the lives of his compatriots. The Maltese Cross, now worn by modern firefighters, is actually an adaptation of a particular crusader insignia, the cross of the Knights of St. John of Jerusalem.

During the crusades, many Knights became firefighters out of necessity. Their enemies had resorted to throwing bombs and sailing war vessels containing naphtha. Hundreds of Knights were burned alive. Others risked their lives to save their brothers in arms from dying painful fiery deaths. Thus these men became our first firefighters and the first of a long list of courageous firefighters.

The Maltese Cross is your symbol of protection. It means that the firefighter who wears this cross is



willing to lay down his/her life for you, just as Crusaders sacrificed their lives for their fellow man so many years ago.
